

A Demolition Permit is required for residential or commercial property prior to demolition of a fixed structure connected to water and/or sewer services within the Town of Pinedale.

Fee

Fee is determined by resolution, refer to www.townofpinedale.us or contact the Town for the fee amount.

Application Requirements

- Completed Demolition Permit application
- Site Plan or sketch of lot and utility locations (provided on 8-1/2" x 11" paper)
- Signatures from the utility companies that the utility has been properly disconnected (signature line provided on application form)
 - o Rocky Mountain Power (Pacific Power): 888-221-7070
 - CenturyLink (Phone & internet): 800-201-4099 (general) or 800-849-2476 (buried cable locating service)
 - o Pinedale Natural Gas: 307-367-4427
- Inspections required: sewer and water cap off (in horizontal at the property line)
- Notify the Town (307-367-4136) at least one day prior to inspection. Inspections will be performed Monday-Friday 8 a.m.-4 p.m.

Notes

- It is the applicant's responsibility to submit the Department of Environmental Quality Asbestos Notice, if required
- Further information can be found at <u>deq.wyoming.gov/aqd/asbestos</u>
- No on-site burning or burying of debris is permitted
- A fire extinguisher shall be available at all times during demolition
- Dust control shall be the responsibility of the permittee
- If you intend to dig, call One-Call of Wyoming at least two business days before your dig (800-849-2476) or (811) for utility locations (free, must provide descriptive locations)
